#### • Jan Kriz, Czech Ministry of the Environment

Ing. Jan Kříž was born in 1976 and graduated from the Faculty of Civil Engineering at the Czech Technical University. During his career he has gained a lot of experience with EU funds and a financial system. He worked at the Ministry of the Environment in the years 2007 - 2010 as Director of the Department of EU Funds and then in the position of Deputy Director and Head the Department of EU Structural Funds at the State Environmental Fund. In years 2010 - 2013 he focused on funding from the Operational Programme Research and Development for Innovation at the Ministry of Education, Youth and Sports first as a Director and later in position of Director General. Currently, he is the Deputy Minister for Section of EU Funds, Economic and Voluntary Instruments at the Ministry of the Environment. He is married and has two kids.

Tomas is an Expert on Participatory Planning and Public Engagement.
