Local authorities play a leading role in climate change mitigation and adaptation. On the one hand over 70% of EU citizens are expected to live in urban areas by 2030. On the other hand city authorities are closer than most to the public. They are the governance level with the best understanding of local people's needs which allows the implementation of policies adapted to local realities. However, long-term planning is crucial for efficient and timely implementation of climate and energy measures at the local level, as it allows municipalities to identify key issues, the most important measures and the most appropriate paths for a green transition.

At the time when the IPCC report of last February highlighted the already present and harmful impacts of climate change and when the Russian war in Ukraine must lead all public actors to question the dependence on fossil fuels that finance the invasion and accelerate global warming; ambitious action for a climate, energy and socially just transition is crucial.

In this context initiatives such as the Covenant of Mayors (CoM) have a crucial role as signatories of the Covenant of Mayors have committed to prepare and implement a Sustainable Energy and Climate Action Plans (SECAPs) before 2030. But local realities differ among municipalities in terms of skills, obligations, resources and obstacles. In addition, unfortunately, when it comes to climate and energy action and targets, the sub-national level has so far been receiving little attention. In order to accelerate local climate action in Europe, **Focus** and the **Unify consortium** are organising regional event on best practices of SECAP development and implementation.

The first part of the event will present good practices of SECAP development, focusing on good practices in the context of insufficient institutional support, limited capacity, financial resources and tools that can help municipalities pre-pare, adapt and raise their climate and energy targets. The second part of the event will focus on good practices in implementation of SECAP measures. The event will be concluded with a roundtable discussion on how to acceler-ate local climate and energy action.
